

Commentary - Prudence - May 2024 (11)

US data came softer than expected in the first half of the month. Although the Fed remains reluctant to offer timing for the next cut, treasury traded strongly. Subsequently, hawkish May FOMC minutes and Fed officials' comments got the market better. Treasury sustained weakness for most of the second half of May until the PCE data was published. The China Politburo meeting outcome boosted market confidence in real estate. The multi-pronged policy saw real estate and real estate-related sectors rebound strongly, especially in equity. In India, the expectation of Modi's landslide victory shortly after the end of the month would likely push India's assets another leg higher. Multiple rating affirmations and upgrades in various parts of Asia credit strengthen confidence while Asia credit spread remains firmly at recent tights.

The portfolio did well this month. Hedges, particularly rates, were down this month as end-of-month PCE data were weaker than expected, lifting treasury higher (yield lower). Event-driven and convertible bond strategies both recorded positive returns. Several key event-driven positions had positive outcomes of which, a few would exit in the next month. In May we took the opportunity to reduce some of our positions given the strong market technical and prepare the portfolio for the typically illiquid summer. As several of our event-driven positions are expected to exit in June and July, the proceeds would give us ample room to reposition the portfolio ahead of the busy second-half result season starting in August.
